**Revenue**

1. Business license revenue was approximately \$1,126,000 as of June 30<sup>th</sup>. This is more than \$296,000 over the amount budgeted.
2. Property tax revenue was approximately \$170,000 over the projected amount. This is due mainly to the assessed values changing due to new construction or home sales.
3. During FY 2019, approximately \$190,000 was transferred from the Hospitality Tax Fund to the General Fund for tourism related activities, such as the replacement of boardwalks.
4. All other revenue account balances were as to be expected as of June 30<sup>th</sup>.

**Expenditures**

1. As of the end of June 2019, approximately \$877,000 has been paid to HDR, Inc. out of the bond proceeds for the WWTP project.
2. As of June 2019, the Town has paid Arcadis \$2,183,767.
3. Public Safety salaries and related accounts were a little over budgeted due to necessary overtime throughout the year.
4. The second installment payment for the 2018 bonds of \$385,531.25 was paid during June 2019.
5. All other expenditure accounts for the year-end were as expected.

**Other**

The Town's auditors will begin field work Monday, August 12<sup>th</sup>.
