**Revenue**

1. Business license revenue was approximately \$763,000 as of February 28<sup>th</sup>. This is approximately 92% of the amount budgeted.
2. All other revenue account balances are as to be expected at this time.

**Expenditures**

1. During February, the Town paid \$15,000 to T2 Systems for a ticketing program that will be used to issue tickets for parking violations.
2. \$14,500 was paid to Morelli Heating and Air for the new HVAC system for Battery Gadsden.
3. As of the end of February 2019, approximately \$671,260 has been paid out of the bond proceeds for the WWTP project.
4. As of February 2019, the Town has paid Arcadis \$591,073.
5. During the month of February, approximately \$380,000 was transferred out of the General Fund to the Sewer Fund. The money was used to pay R.H. Moore for work done on the Poe Avenue sewer line project.
6. All other expenditure accounts are as to be expected at this time.
