Points of Interest
June 30, 2020

Revenue

1. As of the end of June 2020, both business license and building permit revenue were over the projected budget amount by a combined amount of \$519,900.
2. Due to increased assessed values, ad valorem tax revenue is approximately \$156,000 over the projected amount.
3. The Local Option Sales Tax finished above the budgeted projected revenue amounts.
4. The decrease in the revenue received from hospitality and accommodations taxes received between this fiscal year and last fiscal year was approximately \$75,000.
5. Although certain revenues fell slightly short of projections, the Town's revenue finished strong.

Expenditures

1. As of the end of June 2020, approximately \$1,116,027 has been paid to HDR, Inc. out of the bond proceeds for the WWTP project.
2. As of June 2020, the Town has paid Garney Construction \$2,635,868 for the construction of the WWTP.
3. As of June 2020, the Town has paid Arcadis \$3,134,244.
4. As of June 2020, the Town has paid WK Dickson \$239,263 for the engineering for the lift stations.
5. Salary and retirement balances finished above the budgeted amounts in part to the pandemic.
6. As of June 30th, the Town had spent approximately \$55,000 on supplies due to the pandemic. It is uncertain at this time, how much of these expenses will be eligible for reimbursement.
