1. As of the end of November 2020, approximately \$1,338,280 has been paid to HDR, Inc. out of the bond proceeds for the WWTP project.
2. As of November 2020, the Town has paid Garney Construction \$6,446,608 for the construction of the WWTP.
3. As of November 2020, the Town has paid Arcadis \$3,244,375.
4. As of November 2020, the Town has paid WK Dickson \$333,491 for the engineering for the lift stations.
5. As of November 2020, the Town has paid Republic Contracting \$971,817.
6. As of November 2020, all expense accounts were as expected.
7. The Police Department has purchased the two new police cruisers that were budgeted for FY 2021. One of the vehicles had been fully equipped and issued, and the second vehicle has been taken to have its equipment installed.
