The regular meeting of Town Council was held on the above date at 6:00 p.m., all requirements of the Freedom of Information Act having been satisfied.

Chauncey Clark, Mayor Pro-Tem Sarah Church, Councilmember Mark Howard, Councilmember Rita Langley, Councilmember Susan Middaugh, Councilmember Bachman Smith, IV, Councilmember

Mayor O'Neil called the meeting to order at 6:00 p.m. and stated the press and public had been notified in accordance with State Law. There were approximately ten members in the audience, with one member of the media. Mayor O'Neil led the Pledge of Allegiance, followed by the invocation by Councilmember Clark.

## I. FORMAT: Mayor O'Neil opened the floor for public comment.

Seth Abramson, 187 Gordon Street, Owner of Daniel Island Bike Taxi, spoke to Council about his company providing service on the island. He stated that he is going to start a petition for residents to sign in favor of his service on the island.

Tobias Van Buren, 1825 Rifle Range Road, recommended to Council to consider adding rumble strips to the roadway on the southern side of the Ben Sawyer.

Norman Khoury, 1728 I'on Avenue, stated that Council and the Boards should preserve any Officers' and Sergeants' Quarters on the island, instead of allowing changes to be made. He also stated that if he ever got approved for a variance on his home, he hopes Council would then turn him down.

Linda Perkis, 2871 Brownell Avenue, urged to Council to oppose the decision made by the Design Review Board for an addition and change to a Junior Officers' Quarters house.

John Winchester, 2720 Brooks Street, also urged to Council to oppose the decision by the Design Review Board to a Junior Officers' Quarters and prevent any in the future.

Motion was made by Councilmember Smith, seconded by Councilmember Howard, to have Second Reading, by Title Only, Ordinance No. 2016-05, An Ordinance to Amend Chapter 25 Sections 1, 2, 14, 16 and 17 to Increase the Stormwater Utility Fee for Residential and Commercial Parcels, as amended, carried unanimously. A Special Meeting of Town Council will be held on August 1, 2016 at 6:00 p.m. to have Third Reading and Ratification of this Ordinance.

4. Motion was made by Councilmember Middaugh, seconded by Councilmember Church, to have First Reading, by Title Only, Ordinance No. 2016-06, An Ordinance to Amend Zoning Ordinances Regarding Stormwater Management Regulations for Residential and Non-Residential Development: Sections 21-17 "Stormwater Management", carried unanimously.
