The regular meeting of Town Council was held on the above date at 6:00 p.m., all requirements of the Freedom of Information Act having been satisfied.

Caroline Bradner, 328 East Bay, Charleston- works for the Land, Water & Wildlife Program for the Conservation League. The Conservation League applauds the Town's leadership on the issue of plastic pollution and supports the proposed Ordinance.

Susan Middaugh, 2420 Raven Drive- expressed concern regarding removing myrtle trees in the Accreted Land.

Joan Pittman, 2313 I'On Avenue- stated she believes myrtle trees help protect against rising seas, strong winds, collects settlement during storms, etc.

Maria Andrews, 1318 Cove Avenue- supports preserving the maritime forest and believes the forest is protective against storms and Hurricanes and prevents erosion.

Brian Gilhuly, 2118 Pettigrew Street- stated that the Transition Zone is a small percentage of the Accreted Land but the new complexity to the cutting plan would be costly.

Cyndy Ewing, 2514 I'On Avenue- expressed concern regarding the protection and risk factor when removing trees in the Accreted Land.

Dr. Fred Pittman, 2313 I'On Avenue- opposed to cutting the maritime forest except for Station 24. He stated that Station 24 beach path is overgrown.

David Quick, Mt. Pleasant- loves Sullivan's Island, opposes cutting in the Accreted Land.

Motion: Action: Amend Motion under Active Management Directives, Paragraph 2, Band II (40-100') as follows: subparagraph B, strike "and myrtles" and insert "shrubs shall be cut" for the sentence to now read: "All understory and shrubs shall be cut" and add subparagraph C to be "All myrtles within the landward 45 feet of Band II shall be cut".
