#### C. QUESTIONS AND ANSWERS

1. Question: Approximately how many users will be supported?

Answer: Approximately 65.

2. Question: Total number of desktop devices, laptop devices and tablet devices.

Answer: We currently have 45 desktop devices, 18 laptop devices and 15 Surface Pro devices. We have various iPads as well.

3. Question: How many departments/locations will be serviced?

Answer: Administration, Building Department, Municipal Court, Fire Department, Police Department, Maintenance Department and Water & Sewer Department. These departments are in 4 buildings on one campus.

4. Question: How old are each of the computer systems?

Answer: We typically have a 3-5 year rotation schedule for our devices, however, it can vary.

5. Question: What operating system do you use?

Answer: Windows OS for computers and apple/android for mobile.

Answer: Yes. 1.

10. Question: What is your anti-virus program and monthly bill?

Answer: Vipre and we pay approximately \$250/month.
