**Revenue**

1. Business license revenue was approximately \$1,068,000 as of May 31<sup>st</sup>. This is more than \$230,000 over the amount budgeted.
2. Property tax revenue is a little higher than projected. This is due mainly to the assessed values changing due to new construction or home sales.
3. All other revenue account balances are as to be expected at this time.

**Expenditures**

1. As of the end of May 2019, approximately \$855,000 has been paid to HDR, Inc. out of the bond proceeds for the WWTP project.
2. As of May 2019, the Town has paid Arcadis \$2,183,767.
3. All other expenditure accounts for the month were as expected.
