Points of Interest
April 30, 2019

Revenue

1. Business license revenue was approximately \$982,000 as of April 30th. This is more than \$150,000 than the amount budgeted.
2. Property tax revenue is a little higher than projected. This is due mainly to the assessed values changing due to new construction or home sales.
3. All other revenue account balances are as to be expected at this time.
4. Excluding bond proceeds, total revenue, in the General Fund, is approximately \$643,000 over the projected amount as of April 30th due to increases in a few accounts.
5. As of April 30th, excluding transfers from the General Fund, the Water and Sewer Funds are projected to finish around the budgeted amount for revenue.

Expenditures

1. As of the end of April 2019, approximately \$855,000 has been paid to HDR, Inc. out of the bond proceeds for the WWTP project.
2. As of April 2019, the Town has paid Arcadis \$1,842,485.03.
3. As of April 30th, the total expenses record for the Poe/Citadel project was \$609,599.50.
4. All other expenditure accounts for the month were as expected.
