**Revenue**

1. Revenue accounts are as to be expected at this time.

**Expenditures**

1. The first payment on the 2018 bonds was made during the month of December. The total amount paid was \$357,687.51. The accounts are in the Administration Department, account numbers 10-9000-57000 and 10-9000-59500.
2. Approximately \$76,600 was transferred from the General Fund to the Sewer Fund for payments made to HDR for engineering on the WWTP. As of the end of December 2018, approximately \$589,000 has been paid out of the bond proceeds for the WWTP project.
3. All other expenditure accounts are as to be expected at this time.
