Revenue

1. For Fiscal Year 2021, total General Fund revenue finished above the projected amounts. A few factors that have contributed to the overage are business licenses, building permits and FEMA reimbursements. The amounts have not been audited, and there are a few accounts that will be adjusted for accrue revenue.
2. Water and Sewer fees finished slightly above the projected revenue amounts for FY 2021.

Expenditures

1. As of the end of June 2021, approximately \$1,571,090 has been paid to HDR, Inc. out of the bond proceeds for the WWTP project.
2. As of June 2021, the Town has paid Garney Construction \$11,804,740 for the construction of the WWTP.
3. As of June 2021, the Town has paid Arcadis \$3,806,121.
4. As of June 2021, the Town has paid WK Dickson \$528,018 for the engineering for the lift stations.
5. As of June 2021, the Town has paid Republic Contracting \$2,726,857.
6. For FY 2021, total expenditures, excluding capital projects expenditures, finished less than projected.

The auditors will start the audit Fiscal Year 2021 around August 16th.
