**October 31, 2021**

**Revenue**

1. During October 2021, the Town received approximately \$17,000 from FEMA for reimbursements of expenses related to Hurricane Dorian (Fall 2019 storm).
2. As of October 2021, revenues are as expected.

**Expenditures**

1. As of the end of October 2021, approximately \$1,681,246 has been paid to HDR, Inc. out of the bond proceeds for the WWTP project. HDR has been paid for approximately 99.0% of the contract amount.
2. As of October 2021, the Town has paid Garney Construction \$12,336,231 for the construction of the WWTP. Garney has completed 90.31% of the work and the Town has paid 85.31% of the contract. The difference is the 5% retainage.
3. As of October 2021, the Town has paid Arcadis \$3,757,121. Approximately 99% of the work has been paid to Arcadis. Arcadis is putting together the GIS information. The remaining amount to be paid to Arcadis is \$27,346.90.
4. As of October 2021, the Town has paid WK Dickson \$652,551 for the engineering for the lift stations. The engineer has been paid 99.0% of the contracted amount.
5. As of October 2021, the Town has paid Republic Contracting \$3,331,989. Republic has been paid approximately 99.0% of the contracted. There is a 10% retainage per the contract.
6. As of October 2021, Trident Construction, LLC has been paid \$720,698. Approximately, 10% (\$800,777) of the contract has been completed as of October 31<sup>st</sup>. There is a 10% retainage.
7. The Fire Chief's pickup truck was purchased during October 2021. The purchase will be financed with the lease purchase agreement.
8. As of October 2021, all other expenditures are as expected.
