**Points of Interest**  
**January 31, 2023**

**Revenue**

1. As January 2023, the Town has received approximately \$1,695,000 of ad valorem taxes for operating purposes.
2. Between the General, Sewer and Water Funds, interest income is approximately \$42,000 above the budgeted amounts.
3. As of January 2023, all other revenue accounts are as expected at this time.

**Expenditures**

1. As of January 2023, Trident Construction, LLC has been paid \$8,721,484.35. The remainder, including retainage, left to pay per the contract is \$189,000.
2. As of the end of January 2023, Blutide Marine has completed approximately 91% of the boardwalk replacements and the Town has paid \$412,057.30.
3. Some of the supplies accounts for Police and Fire are higher than expected due to purchases of necessary items for the fire station and storage building.
4. As of January 2023, all other expense accounts are as expected at this time.

**Other**

1. Per the timeline, staff will present the first draft of the General Fund FY 2024 budget at the March Council Workshop.
2. During February 2023, the Town will pay off the short-term GO Bonds. The total of the payments will be approximately \$1,800,000.
