RE: Tree Assessment Letter for 1743 Atlantic Ave., Sullivan's Island, SC

Dear Sam,

At your request, we have examined a 23'' + 21'' + 21'' dbh Live Oak tree located left of center on the above referenced property. My findings are as follows:

- This tree measures approximately 84 feet wide by 87 feet wide, and approximately 47.5 feet high.
- This tree is in good vigor with no signs of stress or decline.
- It does have multiple stems with visible included bark between the limb attachments, but shows no signs of attachment failure at this time.
