

# Town of Sullivan's Island, South Carolina Water and Sewer Committee of Council Meeting Minutes Thursday, August 22, 2024

# 1. Call to Order & Freedom of Information Act Requirements:

The Water and Sewer Committee of Council met at 8:45 a.m. on August 22, 2024 at Town Hall, all requirements of the Freedom of Information Act having been satisfied. Present were Council Committee members Justin Novak (Chair), Jody Latham, and Gary Visser. Staff members present were Water and Sewer Manager Greg Gress, Rebecca Fanning, and Bridget Welch. There were no (0) members of the public and no (0) members of the media present.

Chair Justin Novak called the meeting to order at 8:49 a.m., and stated the press and public were duly notified pursuant to State Law.

# 3. Communications/Additional Items from WWTF Manager, Greg Gress

a. Construction updates as to the Lift Stations and WWTP

Greg Gress stated there has been some discolored water due to Tropical Storm Debby. The water is safe to drink but it may take a few days to resolve.

He also mentioned that AT&T has been installing fiber on the Island and they collapsed four marked sewer lines and cut a water line. They now have a stop work order and will be closely monitored moving forward.

There were no major issues during Tropical Storm Debby. Mr. Gress stated they recorded 10.2 inches of rain over the course of four days. All Sanitary System Overflow (SSO) issues were cleaned up and will be reported to DHEC. Mr. Visser and Mr. Gress gave some background on SSOs, and the ones created by Debby specifically.
