- 1. To be responsible for payment for the service rendered hereunder until the contract is terminated in accordance with section 5 hereinafter written.
- 2. That the water supply and sewer service shall be measured by water meter provided by the Town and that no other use will be made of the water than that stated above without first obtaining permission therfor.
- 3. That in consideration of the installation and maintenance expenses assumed by the Town, to pay the necessary fees in accordance with the current Rates & Fees schedule established and amended from time to time by resolution of council; a minimum charge for water and sewer service whether or not any water has been used. Where no water supply has been furnished to property line, a water and sewer basic facility charge shall be charged for as prescribed by Ordinance and in accordance with the minimum charge for water and sewer as set by the current Rates and Fees schedule of the Town.

The standard sewer tap charge and water meter charge are in accordance with the current Rates & Fees schedule. This includes tap charge only; all service lines to be installed by lot owner, or his or her contractor.

- 4. That this application becomes a binding contract upon both the applicant and the Town when signed. It is agreed that upon failure to pay for either water or sewer service as herein provided the Town is authorized to terminate both water and sewer service or either and may place a lien on the property.
- 5. That this contract for water supply and sewer service shall expire at the end of the next succeeding fiscal year from date of application, but shall continue in force by renewal without act or notice of either party to the other from year to year unless ten (10) days notice in writing shall have been given by either party to the other of a desire to terminate the contract at the expiration of the fiscal year.
- 6. That the Town shall retain title to all property furnished and installed by it, and the applicant shall be responsible for keeping it clear and unobstructed and for the safe keeping of all property of the Town on his or her premises. The applicant agrees that the town's representatives shall have free access to the premises at all reasonable hours for the purpose of inspection, repairing, and/or removing, and reading of meter.
- 7. That the quantity of water recorded by the meter shall be conclusive and binding upon both the applicant and Town except when the meter has been found to be defective or ceases to register the quantity of water. In cases where the meter is found to be defective or ceases to register, the quantity of water supplied shall be determined by average registration of another meter for a period of thirty (30) days or for the same meter after being repaired.
- 8. That no allowance shall under any circumstances be made for water used, lost, wasted through leaks, carelessness, neglect or otherwise after the water has passed through the meter.
- 9. Meters will be read monthly and bills rendered in accordance therewith. All bills to be due within (10) days of rendition, and to be paid in full not later than fifteen (15) days from date of bill.
- 10. The town will make every effort to give such continuous and uninterrupted service, but nothing in this contract shall be construed as a guarantee, covenant to agreement to give such continuous and uninterrupted service, and the applicant hereby waives all claims for damages of whatsoever nature growing out of failure on the part of the Town to give a continuous and uninterrupted service.

- 11. The Town hereby undertakes to make every effort to maintain a high quality of water supply under all conditions and it is mutually agreed by and between the applicant and the Town that the liability for damages in case of failure upon the part of the Town to maintain the high quality of water supply shall be limited to the value of water supplies applicant during the period of time of such failure.
- 12. That the applicant is to pay for the water supplies and sewer service in accordance with the current Rates and Fee schedule of the council and is to be bound by the rules and regulations of the Town the same as if herein incorporated.
- 13. That the applicant is not now in default to the Town for service rendered applicant at any other premises. And it is further agreed upon the part of the applicant that the Town is authorized to charge on this account for water and sewer service charges, and meter connections and other fees incurred by the applicant at this or any other premises during the life of this contract.
- 14. The Town is directed to place meter on the above service address, upon proper receipt of all tap, connection, installation fees, as soon as possible.
- 15. A deposit per meter will be required of all water or sewer users in accordance with the current Rates and Fee schedule, said deposit to be paid as security for charges and fees hereunder at the time the contract for water service is made, provided, however that this requirement for a deposit may be waived where the contract for water service is with the property owner and where the property owner, in writing, assumes responsibility for payments of all amounts due for water and sewer service furnished said property.
